

## **Summer Student Refund Dates & Course Fee Refund Policy**

During the initial days of each term, students who drop a course will be eligible for a 100% refund. Following this period, students will not be eligible for any tuition refund. Students may continue to withdraw until 75% of the course, in weeks, has been completed.

The 100% tuition refund date will be based on the length, in weeks, of each term. The date is calculated using the first official day of the term, not the first course meeting.

Summer first session 5-week courses (May 12th – June 13th)

Last day to drop course with a 100% refund – May 13th

Courses dropped after May 13th will receive no refund

Last day to withdraw from 5-week classes is Friday, June 6th.

Summer 10-week Health Science courses (May 27th – August 9th)

Last day to drop course with a 100% refund – June 3rd

Courses dropped after June 3rd will receive no refund

Last day to withdraw from 10-week classes is Friday, July 25th.

Summer 8-week courses (June 16th – August 9th)

Last day to drop course with a 100% refund – June 19th

Courses dropped after June 19th will receive no refund

Last day to withdraw from 8-week classes is Friday, July 25th.

Summer second session 5-week courses (July 7th – August 9th)

Last day to drop course with a 100% refund – July 8th

Courses dropped after July 8th will receive no refund

Last day to withdraw from 5-week classes is Friday, August 1st.

## **Fall Student Refund Dates & Course Fee Refund Policy**

During the initial days of each term, students who drop a course will be eligible for a 100% refund. Following this period, students will not be eligible for any tuition refund. Students may continue to withdraw until 75% of the course, in weeks, has been completed.

The 100% tuition refund date will be based on the length, in weeks, of each term. The date is calculated using the first official day of the term, not the first course meeting.

Fall 16-week courses (August 25, 2008 – December 20, 2008)

Last day to drop course with a 100% refund - Friday, September 4th

Courses dropped after September 4th will receive no refund

Last day to withdraw from 16-week classes is Friday, November 14th.

Fall first session 8-week courses (August 25, 2008 – October 14, 2008)

Last day to drop course with a 100% refund – Thursday, August 28th

Courses dropped after August 28th will receive no refund

Last day to withdraw from first session 8-week classes is Friday, October 3rd.

Fall second session 8-week courses (October 15, 2008 – December 20, 2008)

Last day to drop course with a 100% refund - Monday, October 20th

Courses dropped after October 20th will receive no refund

Last day to withdraw from second session 8-week classes is Wednesday, November 26th.
