WHEREAS, Ivy Tech Community College of Indiana currently holds cash of approximately \$1,060,000 that it has received as partial distributions from the estate of Peter P. Froehde, deceased, and

WHEREAS, The College received those distributions under the provisions of paragraph 5 of ITEM X of the decedent's Last Will and Testament, which provisions read as follows:

"Whenever this trust shall terminate as to the last of the above named trust beneficiaries designated in this Item, and by reason of the death or marriage of such beneficiaries as herein provided, then this trust shall cease and terminate in its entirety. Upon such termination, all of the trust estate then in the possession of the Trustee, together with an accumulated or undistributed income, shall be transferred, conveyed, and distributed in equal shares, share and share alike, to Rose-Hulman Institute of Technology, Terre Haute, Indiana, and Indiana Vocational Technical College, Region 7, Terre Haute, Indiana, or to their individual successors and for such unrestricted uses as the governing body of each respective institution deems advisable.", and

WHEREAS, Ivy Tech Foundation, Inc. is an institutionally related foundation organized and operating under the Indiana Nonprofit Corporations Law of 1991 (IC 23-17) to solicit, receive, administer, and distribute private donations, grants, and bequests for the benefit of the College, and

WHEREAS, The Foundation has substantially more experience than College in administering private donations and bequests that are designated for a particular administrative region or program of the College, and

WHEREAS, It is the College's desire that the Foundation assume responsibility for administering the funds the College previously received as partial distributions from the estate of Peter P. Froehde, deceased, and

WHEREAS, The Foundation is willing to receive those funds and to administer them for the benefit Region 7 of the College as provided for in paragraph 5 of ITEM X of the decedent's Last Will and Testament, and

WHEREAS, The College has been advised by a representative of the State Board of Accounts that the agency will treat any transfer of those funds from College to Foundation as an audit exception unless College first receives a court order authorizing the transfer, and

WHEREAS, Officers of the College and the Foundation joined together on July 26, 2005 in filing a petition with the Vigo County Superior Court, Probate Division requesting such an order from the Court;

NOW THEREFORE BE IT RESOLVED, that the State Trustees do hereby go on record in support of the petition filed with the Vigo County Superior Court, Probate Division on July 26, 2005, a copy of which petition is attached to this resolution, and

FURTHER BE IT RESOLVED, that the State Trustees do hereby authorize and direct the Treasurer of the College to effectuate such a transfer of funds from the College to Ivy Tech Foundation, Inc. if the Judge of the Vigo County Superior Court, Probate Division issues an order authorizing the transfer, and

FURTHER BE IT RESOLVED, that the State Trustees do hereby request that any additional distributions from the estate of Peter P. Froehde, deceased, designated for Region 7 of the College be made directly to Ivy Tech Foundation, Inc. to be administered by the Foundation for the benefit Region 7 of the College as provided for in paragraph 5 of ITEM X of the decedent's Last Will and Testament.


