

Student/Employee Acknowledgement

Ivy Tech Community College is committed to your health and safety and has been hard at work preparing for the fall semester as we welcome more of you back on campus. This includes enhancing our cleaning and sanitizing protocols, rearranging spaces to allow for social distancing, and adjusting our course offerings to allow for greater flexibility and control of our on-campus census.

However, we cannot do this alone. We are asking for every student and employee to help us to reduce the spread of COVID-19 in our communities.

I acknowledge:

- I understand that Ivy Tech Community College has adopted a Use of Face Coverings Policy that currently requires the use of a mask or face covering when in an Ivy Tech building, at an Ivy Tech event, or when outdoors on Ivy Tech property and social distancing is not possible. I understand that the policy is available, in full, at www.ivytech.edu/covid-19.
- I understand that Ivy Tech Community College has also adopted a COVID-19 Positive Case Policy that can be found at www.ivytech.edu/covid-19.
- I will respect and provide social distancing of 6 feet whenever possible.
- I understand that the COVID-19 pandemic is still progressing and I will adhere to future directions and policies of Ivy Tech Community College or public health officials aimed at slowing the spread of COVID-19.
- I will conduct a self-screening each day prior to arriving at campus and I will not come to campus if:
 - I have a fever of 100.4° or greater, or
 - I have two or more symptoms [listed by the Centers for Disease Control and Prevention \(CDC\)](#) of COVID-19, or
 - I have been exposed and/or have reason to believe I have been exposed to COVID-19, or
 - I have been advised by a health care or public health professional to self-quarantine, self-isolate, or otherwise refrain from public activity due to actual or possible infection of COVID-19.
- If I am identified as a close contact of anyone determined to be positive for COVID-19, I will self-quarantine for fourteen days after exposure or as directed by a public health official.
- If I am determined to be positive or presumed positive for COVID-19, I will report this to Ivy Tech Community College through the reporting link found at www.ivytech.edu/COVID-19, effective Monday, August 24, 2020.
- I understand that if I am tested for COVID-19 because I have symptoms as described by the CDC, was directed to be tested by a healthcare provider, or directed to be tested by a public health official, I must not return to campus until my test results are available.
- I understand that if I test positive for COVID-19 or am presumed positive for COVID-19, I will be required to self-isolate in [accordance with CDC guidelines](#) and not permitted on campus.

I have read, understand, and agree to the expectations described on this acknowledgment. I further understand that these expectations may change as the College adjusts to guidance from the CDC, Indiana State Department of Health, and other public health officials.
